





The buildable site is a one acre steep slope on the side of Shadow Mountain, with varying spectacular views in all directions.


The organization and massing were generated by a strategy that integrated the topography to form three interconnected elements defining a courtyard as the referential outdoor space. The parti is a reinterpretation of a hill town/courtyard house.

The entry, ground floor level houses a four car garage, mud room and entry gallery; all accessed from an autocourt, which also engages an exterior stair, connecting to the courtyard on the second level.


From the entry gallery there is direct access vertically to the second level, as well as to a underground screening room, game room, wine cellar, spa and exercise space.

The second level houses the family room, kitchen, chef's kitchen pavilion; the living and dining rooms, guest bedroom, three children's bedrooms and a playroom.


The third level houses two studies, a guest bedroom and the master bedroom suite, which accesses a terrace overlooking and connecting to the courtyard and pool, one level below.



NORTHWEST ELEVATION




SOUTHEAST ELEVATION




NORTHEAST ELEVATION




SECTION THROUGH GARAGE, FAMILY ROOM, COURTYARD




SECTION THROUGH ENTRY HALL, GALLERIES



SECTION THROUGH EXERCISE, BEDROOM, PLAYROOM, MASTER BEDROOM





敷地は、シャドー・マウンテンの山腹にある1エーカーの急斜面で、どの方向にもさまざまな変わる壮大な景色が望める。

その平面構成と立体的な広がり、内部と関係を持つ戶外空間として中庭の境界をつけながら、互いに連結する3つの要素を形成するために、地形と合体させる作戦から生まれている。設計の基本概念は丘の街とコートヤード・ハウスの再解釈である。

入り口のある1階には4台収容できるガレージ、マッドルーム、玄関ギャラリーがあり、そのすべてに駐車場から直接入れる。駐車場は外階段や2階のレベルにある中庭ともつながっている。

玄関ギャラリーからは、2階へも、また地階の映画室、娯楽室、ワインセラー、スパ、エクササイズ室へも直行できる。

2階には家族室、台所、シェフのキッチン・パビリオン、居間と食堂、客用寝室、子供の寝室3つと遊戯室がある。

3階にはスタジオが2つ、客用寝室と主寝室があり、見晴らしを楽しめるテラスが付いている。テラスから1階下の中庭とプールに出られる。

Structural system: Poured in place concrete foundation, architectural concrete and structural steel frame

Major materials: thermal finish black granite cobbles, thermal finish gray limestone paving and cladding, architectural concrete, stainless steel windows and doors with anti-reflective insulated low E glass, pre-weathered zinc flat seamed siding and standing seam roofing, exterior; honed gray limestone floors, structural glass floors, engineered wood floors, carpet, veneer plaster walls, architectural concrete, white oak doors and frames, stainless steel cabinets, wood cabinets and paneling, interior
